EXECUTIVE VICE PRESIDENT REPORT

Whitmore introduced Resolution 2020-8 (Authority) and Resolution 2020-1 (Corporation) regarding Tramway financing with Meinke asking for any questions.

Upon motion by Conley, seconded by Magana-Cuellar and carried, to approve Resolution 2020-8 of the Mount San Jacinto Winter Park Authority and Resolution 2020-1 of the

Mount San Jacinto Winter Park Corporation approving an installment sale agreement, irrevocable refunding instructions and an assignment agreement with respect to financing a not to exceed amount of \$15,000,000 for improvements to the Palm Springs Aerial Tramway and other matters pertaining thereto. Conley-Aye; Freet-Aye; Magana-Cuellar-Aye; Nestande-Aye; Ogburn-Aye; Ohlfs-Aye; Stuart-Aye. Resolutions approved.


Whitmore requested that the ticket pricing discussion be brought back to a November board meeting. Nestande asked if we could conduct pricing comparisons. Freet agreed that discussion be moved to next month. Conley asked for pricing of Squaw Valley and South Shore Lake Tahoe. Ohlfs went to Table Mountain Aerial Cableway website (in South Africa) tram and (with currency conversion) they are approx. \$24 per ticket. Ohlfs would like to delay discussion until November, but recommends an even \$30 price (rather than \$29.95). Freet would like us to consider different pricing for time of day and time of year.
